- This is a co-ed, slow-pitch, double elimination tournament.
- 9-12 players per team (2 female minimum in which they MUST be on the field at all times).
- Adults are welcomed to participate with their youth; however, Kids MUST outnumber adults (no more than 3-4 adults).
- Each game is 1 hour long. If there is a tie, the game will continue until one team scores without a response.
- There is a 7-homerun limit (per game). All others are outs.
- Each batter starts with a 1-1 count.
- Inning changes after 7 runs or 3 outs (whichever happens first)
- Batting order must be Male, female, male or vice versa until all females have batted.
- Game line-ups are due BEFORE each game.
- Batting order does not change unless there is an injury.
- Teams must be present and ready to play first game by designated time. If not, tardiness will result in a forfeit of game.
- In pinch-running, *PINCH-RUNNERS ONLY PERTAINS TO FIRSTBASE*. Females must ONLY run for females; males must ONLY run for males. *Each pinch-runner must be either the last male and or female out per the previous inning.*
- NO alcohol/tobacco (this is a church event)
- 0 tolerance for fighting (again, this is a church event)

- NO profanity - 1 warning and then points from team will be deducted for every other offense.
- Each team is expected to help keep ballpark clean! (as they were kind to allow us to use it)
- Each team's entry fee and team waiver release MUST be completed and turned in BEFORE 1st game.

❖ Fouls:

Each player get 1 courtesy foul (this will be after the first foul -hit ball). A third foul results in strike three and the batter is out.

❖ Intentional walk rule:

Each team can only intentionally walk ONE batter, ONE time a game. If the batter intentionally walked is a male, and there are two outs, the male automatically goes to 2nd. The female batting behind him has the option to either take her turn batting or automatically advance to 1st.

- All coaches must meet on the field at 8:00am.
- I will meet with coaches at 8:30am to further discuss rules and game play.
